Consignment Agreement

Welcome! The Singing Lady is so pleased that you wish to become part of the consignment world!

This is how it works:

- We do everything by appointment - no surprise drops to the store are permitted
- All items must be in tip top shape. On a scale of 1-10 the condition should rate no lower than an 8
- It is your responsibility to bring all items to the store and to take them away if they are not sold
- All linens **MUST** be washed and pressed when brought to the store
- All lamps must come with shades that are in very nice condition
- We do not take chipped, broken, badly stained, dirty or damaged goods - if anything arrives requiring cleaning it will not be accepted for consignment
- We absolutely do not take upholstered furniture or rugs exposed to smoke or pet hair

Consignment Terms

- The consignment split varies depending on the selling price of the item.
 - You receive 50% for items that sell for \$50 and above.
 - For items that sell for less than \$50 your portion is 45% of the selling price.
 - Splits are calculated based on the price sold at the time of sale.
- Items are consigned for a period of 180 days (6 months) with multiple automatic markdowns during the consignment term.
 - After 30 days the price is reduced by 15%
 - After 60 days the price is reduced by an additional 10%
 - After 90 days the price is reduced by an additional 10%
- Throughout the consignment period, pricing and discounts are at the **sole discretion of the store**. We reserve the right to negotiate the selling price in good faith on offers made by customers regardless of the automatic markdown time frames. The Singing Lady Consignment has the right to offer any special pricing, promotions or discounts at any time during the consignment term. Please Initial
- All items dropped off are left with us with the intent to consign. We do not price items on the spot or from photos. Prices are set once the items are evaluated and appraised at our discretion.
- If you wish to reclaim items before the contract period ends, there will be an early termination charge of 15% of the starting price. Please Initial
- Not all items left with us are suitable for consignment. We may decline items for a number of factors including, condition, marketability, etc. For declined items we will contact you by email or phone letting you know that they can be picked up within 7 days or donated. If the items are not picked up within 7 days, we will assume that you are donating the items to the store. Please Initial
- It is your responsibility to keep track of the status of your items including the expiration date of unsold items. Log-in to **consign.thesinginglady.com** to view detailed information about your account. Unsold items must be picked up within 7 days after the expiration date or they become the property of the store. **Please note that due to the upcoming store closure all expired items MUST be retrieved by Wednesday, December 18, 2023.** All pick-ups must be done during our business hours . Please email or call us to let us know the date/time you will be picking up your unsold items. As a courtesy, please give us **24 hours notice** to have your expired items ready for pick-up. Please Initial

Once your item sells:

You, the Consignor are paid once the item sells. Cheques are issued between the 15th and 20th of each month for the previous month's balance of \$25 or more. We will notify you by email if there is a cheque issued to your account. Amounts under \$25 remain in your account until you have accumulated \$25 in your account. We do NOT issue cash payouts. You also have the option to apply your account credit towards any merchandise for sale in the store.

A \$3.00 processing fee is applied to each payout. Unclaimed, lost or stale dated cheques will not be re-issued.

The Singing Lady has the right to photograph the item(s) being sold and retain the images for use in any materials ie; website features and literature.

Liability

This is a consignment store where customers are able to handle items. We do our best to safeguard your items, but we are not responsible for damage or loss. Our store is also not liable for loss of consigned items due to; fire, theft, natural disasters or any other unforeseen circumstance.
